

## TERMS AND CONDITIONS OF USE - "PRYOR PORTAL" PLATFORM

### 1. Acceptance of the General Terms and Conditions of Use

These Terms and Conditions of Use ("Terms") govern the use of the "PRYOR PORTAL" platform by the Users made available to the clients of Pryor Global, as well as collaborators, lawyers and business partners, to request assistance related to the legal representation process, such as document signing and release of cash flow.

When using the platform, the User fully accepts the present rules and undertakes to follow them, under risk of application of the applicable penalties. The User also hereby confirms acknowledgment of the Privacy Policy of Pryor Global, available [here](#)

Users who do not agree with the rules stated in these Terms will not be able to access and use the platform and use the services.

### 2. Provided Services

This Term applies to regulate the use of PRYOR PORTAL, a platform made available to the clients of Pryor Global, as well as lawyers and business partners, to request assistance related to the legal representation process, such as document signing and release of cash flow.

All technical solutions will be used to allow access to the service 24 (twenty-four) hours a day, 7 (seven) days a week. However, navigation on the platform may be interrupted, limited or suspended for updates, modifications or any action necessary for its proper functioning.

### 3. Registration on "Pryor Portal"

In order to use "PRYOR PORTAL", all Users will be provided with login and password, prior registered on the platform by Pryor, by means of registration of the following data: User name and e-mail.

At the first access to the platform, after accepting the Terms of use of the platform, the User must change the initially registered password, creating a new personal, non-transferable and confidential password. The User may also complement the registration data, undertaking responsibility for the veracity and the precision of the provided data.

We recommend it to be a strong password, containing at least 8 (eight) characters, including uppercase and lowercase letters, numbers and special characters, and difficult to guess. It is not recommendable to use sequence of letters and numbers, names of close people and/or special dates. The Users must assure the security of their password, and must change it immediately if they become aware or suspect that it has been discovered by a third party.

In case of forgetting or losing the password, the User can request change by means of a procedure via registered e-mail, using option "I do not remember my password" available on the home page of "PRYOR PORTAL".



In case of incorrect, untrue or unconfirmed information and in case of refusal to correct them or send documentation that proves correction, Pryor Global reserves the right not to complete the registration in progress or yet to block the existing registration, preventing the USER from using the on-line services until, at the discretion of Pryor Global, the irregular situation is regularized. Pryor Global reserves the right to impede, at its discretion, new registrations, or cancel the registration, which has already been made, in case as serious irregularity is detected, upon its analysis, or demonstrates deliberate attempt to circumvent the rules described herein, mandatory for all Users. Pryor Global will also act this way if the User fails to fulfill any obligation set forth in the present Terms.

#### **4. User's Obligations**

- ✓ The User hereby undertakes not to disclose the login and password data to third parties, considering that any service request made using his/her login and password is under his/her sole responsibility.
- ✓ The User is exclusively responsible to keep the referred password confidential and secure, avoiding undue access to the personal data.
- ✓ All and any activity carried out using the password will be under the User's responsibility, who must, by means of the contact channels indicated in these Terms, inform immediately about any suspected or confirmed unauthorized use of his/her account.

#### **5. Obligations of Pryor Global**

- ✓ Provide the Users with access to "PRYOR PORTAL" to request assistance related to the legal representation process, such as document signing and release of cash flows.
- ✓ Fulfill all legal obligations, including, but not limited to, the Consumer Defense Code and the General Data Protection Law.
- ✓ Protect the confidentiality of all information and records related to the Users by means of storage on servers or any other high-security means.

#### **6. Intellectual Property**

All elements and/or tools found on the Platform, especially those owned or licensed by the company identified in the preamble to these Terms, are subject to intellectual rights in accordance with the Brazilian laws and the international treaties and conventions Brazil is a signatory to.

The available elements and/or tools cannot be used, copied, reproduced, distributed, transmitted, spread, displayed, sold, licensed or otherwise exploited for any purpose whatsoever without prior consent by Pryor Global in writing.

#### **7. Privacy and Protection of Personal Data**

Pryor Global collects and uses the User's personal data during their navigation on the Platform. See Pryor Global's practices regarding the use of your personal data in the Privacy Policy.

At any time, the content of these Terms of Use, or part thereof, may be modified for adaptation and insertion intended for improvement of the available services.
